- 4. The first meeting of the High Needs Sub-Group was held on Monday 27<sup>th</sup> November. The sub-group terms of reference were agreed (see Appendix 1). As noted in the sub-group minutes (Appendix 2 commercially in confidence), the sub-group discussed and agreed to recommend for Schools Forum approval:

#### 1. Low Incidence Needs Service (LINS)

An uplift request of £25,000 was taken to Darlington Borough Council's People's Directorate Leadership Team (DLT) because of the statutory duty to provide this service. DLT agreed the need to fund this current financial year with a view to review before September 2024. The Sub-Group agreed that this was a reasonable request and not to disrupt service delivery, and it was noted that this is also an opportunity to review the delivery model of the service.

## 2. Resource Base Update - Commercially in Confidence

- Heathfield base for Cognition and Learning
- Northwood base for Speech and Language

The current position on places at the above resource bases was noted. The rationale for reviewing the bases was agreed.

## 3. Beaumont Hill Update - Commercially in Confidence

The position relation to places was noted and the relevance of the progress of the Tees Valley Free School.

#### 4. Outreach Services Update and Areas of work moving forward

The review of outreach services has commenced. Services have been informed. The subgroup agreed that higher funded services should be priorities for review, therefore, agreed a priority review of the Social Communication Outreach Service, bearing in mind the reviews as per the resource base position explained previously.

Since the sub-group met The Rydal Academy have requested an uplift for the Traveller Education Service (TEAS). (See Item 11)

## Recommendations
