LOCAL DEVELOPMENT FRAMEWORK CORE STRATEGY EXAMINATION

Re-insertion of appropriate references to the North East of England Plan January 24th, 2010

1. Introduction

1.1 This statement sets out the relationship of the Core Strategy to the Regional Strategy, and outlines the appropriate references to the 'North East of England Plan Regional Spatial Strategy to 2021' (the Regional Strategy, published in July 2008, hereinafter referred to as the RSS) that the Council is seeking to reintroduce into the Core Strategy. The statement has been prepared as a result of the Council's reconsideration of the status of the RSS, and in response to a letter from the Examination Inspector to the Council dated 6th January 2011(ID/8). It complements the statements already prepared for the Examination by the Council (DBC002 to DBC006).

2. Background

- 2.1 The RSS was published in 2008 and regard was had to it in the preparation of the Core Strategy Preferred Options and Revised Preferred Options. During the final stages of preparing the Core Strategy: Publication Draft (CD009), on 6th July, CLG issued a parliamentary statement revoking all regional strategies, indicating that Regional Strategies no longer form part of the development plan. A 'Dear Chief Planner' letter issued the same day (SD082) advised of the revocation with immediate effect. The Council considered the implications of this at its meeting on 22nd July where the Publication Draft Core Strategy was considered. The covering report to Council (CR001) considered the implications of RSS revocation and concluded that the removal of the RSS from the statutory development plan did not require a rethink of the development strategy for two key reasons:
 - (a) many of the planning principles in the RSS are now enshrined in national planning policy, with which the Core Strategy has to have consistency, in order to be found sound.
 - (b) the Council had significant input into the preparation of the RSS, ensuring that its provisions for the amount and type of development proposed for Darlington fitted in with the Council's own ambitions for the Borough. Examples include the identification of Central Darlington as a focus for regeneration, and the continued inclusion of Faverdale as a key employment location.
- 2.2 The Council resolved that the Core Strategy Publication Draft be agreed and published (Minute 17 (4)(a) refers).
- 2.3 The Publication Draft Core Strategy included no references to the RSS, but included justification for the policies, for example, from more up to date sub-regional and local studies and strategies that have also been relied upon in preparing the document (see Appendices 2 and 3 of the Core Strategy). For matters like housing numbers, the justification was found in documentation submitted by the Council and its partners whilst the RSS was being prepared, and in other regional strategies, such as the regional economic strategy.
- 2.4 After the Council submitted its Core Strategy to the Secretary of State for Examination on the 29th October 2010, a High Court judge found that the Secretary of State had acted unlawfully by revoking Regional Strategies and had used his powers improperly ([2010] EWHC 2866 (Admin)). The effect of this decision was to re-establish Regional Strategies (in this case, the RSS) as part of the development plan. However, on the same day, in a

'Dear Chief Planner letter (SD083), CLG indicated that local planning authorities should still regard as a material consideration the Government's intention to abolish Regional Strategies in the Localism Bill. A legal challenge to this letter has in turn been made, but at the time of writing, no judgement has been made on it.

2.5 On 6th January, the Examination Inspector wrote to the Council (ID/8) requesting a submission to the Examination setting out the Council's re-insertion of appropriate RSS references. The Council accepts that, at this time, the RSS is part of the development plan and that to be found sound, the Core Strategy needs to be in general conformity with the RSS. However, it is also wants to ensure the continuing relevance and longevity of the Core Strategy over the medium to long term, and therefore is proposing re-introduction of references to the RSS in a manner which will not make the Core Strategy appear dated immediately if and when the RSS is legally revoked.

3. Re-insertion of appropriate RSS References: Proposed Minor Amendments

- 3.1 The Council is therefore seeking to make further minor amendments to the submitted Core Strategy (DC009+CD009) to insert appropriate references to the RSS. These minor amendments are proposed on the understanding that the evidence base supporting RSS policies also supports several Core Strategy policies, and with the intent that any future revocation of the RSS as a plan, will not materially affect the soundness of the Core Strategy.
- 3.2 The proposed minor amendments are set out in **Appendix 1**.

4. Conclusion

4.1 The Council considers that making these minor amendments and preparing this statement will help to demonstrate that the Council has had due regard to the RSS in preparing its Core Strategy, and that the Core Strategy is in general conformity with the RSS. The Core Strategy is therefore considered legally compliant with these requirements.

The RSS sees Darlington as having a key role in contributing to regional economic growth, and a gateway to the Tees Valley and North East. It specifically identifies brownfield opportunities in Central Darlington as a priority for development, and land in the Faverdale and Heighington Lane areas as key employment locations. It also acknowledges that the Borough's road and rail infrastructure, together with Durham Tees-Valley Airport on the eastern boundary of the borough, could make it pivotal as a gateway and interchange in helping to achieve a regional renaissance.
