

**DARLINGTON BOROUGH COUNCIL  
EXPERIMENTAL ORDER No.1 2021**

Darlington Borough Council ('the Council') in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') and of all other enabling powers; and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order. The Darlington Borough Council (Moving Traffic) Order 2019 ('the Moving Traffic Order') is amended as follows:

1. The Article detailed in Schedule One to this Order shall be added to the Moving Traffic Order.
2. The road detailed in Schedule Two to this Order shall be deleted from Schedule 30.03 to the Moving Traffic Order.
3. The Schedule detailed in Schedule Three to this Order shall be added to the Moving Traffic Order.
4. Pursuant to Section 10(2) of the Act the Director of Economic Growth for the time being of the Council, or any other such person authorised to carry out those duties, may, if it appears to that officer or to that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which the roads affected by this Order run, modify or suspend this Order or any provision thereof.
5. The provisions of this Order shall cease to be in force eighteen months after it is made unless a subsequent Order is made to continue them in force indefinitely.
6. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

This Order is entitled the Darlington Borough Council Experimental Order No.1 2021 and shall come into operation on the 12<sup>th</sup> April 2021.
