

**DARLINGTON BOROUGH COUNCIL  
(PUBLIC FOOTPATH 5 AND PUBLIC BRIDLEWAY 4  
PARISH OF LOW CONISCLIFFE)  
DIVERSION ORDER 2017**

This Order is made by Darlington Borough Council under Section 119 of the Highways Act 1980 because it appears to the authority that it is in the interests of the owner of the land crossed by the footpath and bridleway described in paragraph 1 of this Order and it is expedient that the lines of the path and bridleway should be diverted.

Manners Farms Limited of Thornton Hall Cottages, Staindrop Road, High Coniscliffe, Darlington DL2 2NB have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new sites of the path and bridleway into a fit condition for use by the public.

**BY THIS ORDER**

1. The public footpath and bridleway over the land situate at Coniscliffe Grange Farm and shown on the attached map and described in Part 1 of the Schedule to this Order ('the Schedule') shall be stopped up after 14 days from the date of confirmation of this Order.
2. There shall at the end of 14 days from the date of confirmation of this Order be a public footpath and bridleway over the land situate at Coniscliffe Grange Farm and shown on the attached map and described in Part 2 of the Schedule to this Order.

**DESCRIPTION OF SITES OF EXISTING PATH AND BRIDLEWAY IN  
LOW CONISCLIFFE**

Footpath No.5	Starting at Point T, OS Grid Reference NZ 25760 15558 on Staindrop Road, going south east across arable field to Point V, NZ 25421 15436 at farm yard. Width undefined.
Bridleway No.4	Starting at Point A, NZ 25523 15617 on Staindrop Road going south through farm buildings to Point B, NZ25391 15371 south of the farm yard. Width varies

## PART 2

### DESCRIPTION OF SITES OF NEW PATH AND BRIDLEWAY IN LOW CONISCLIFFE

Footpath No.5	Starting at Point T, NZ 25760 15558 on Staindrop Road, going south along the headland of an arable field to Point W, NZ 25701 15413 and then east to Point X, NZ 25733 15399. Then south to Point Y, NZ 25693 15270 on an existing farm access track. Then west along the track to meet an existing bridleway at Point B, NZ 25391 15371 south of the farm yard. Width 1.5 metres Limitation - Single step wooden stile in hedge at Point T, NZ 25760 15558 compliant with BS 5709.2006
Bridleway No.4	Starting at point C, NZ 25309 15666 on Staindrop Road going south alongside the motorway on a field headland and then farm access track to point D, NZ 25214 15401. Then east to meet existing bridleway route at point B, NZ 25391 15371 south of the farm yard. The route between points D and B will be upgraded to bridleway rights. Width 3 metres Limitation - Bridle gate (operable from horseback) at Point C, NZ 25309 15666 compliant with BS 5709.2006.




