No. and date of entry	Description of the land, reference to the register map, registration particulars etc.
1 20th May 1969	Those pieces of land called Brafferton Village Green containing 1.55 acres or thereabouts in the Parish of Brafferton in the Rural District of Darlington as marked with green verge lines inside the boundaries on sheet 49/6 of the register map and distinguished by the number of this register unit. Registered pursuant to application No.226 made 9th June, 1968 by Mr. Douglas Longstaff, Chairman of the Brafferton Parish Meeting, c/o "Vielle Ecole", Brafferton, Nr. Darlington on behalf of the Parish Meeting. (Registration Provisional)
2. 1st June, 1973.	The registration at entry No. 1 above, which was disputed, became final on the 1st June, 1973, with the following modification:- that the words " but excluding the areas coloured violet and marked with the letters A,B,C,D,E and F" follow immediately after the words "of the register map" in Entry No. 1 above.
3. 4th March 1980	Registration Amendment - part of the land comprised in this register unit, hatched violet and identified by the letter "L" on sheet 49/6 of the register map ceased to be Town or Village Green on 1st September 1975 and is removed from the Register pursuant to application No. 742 made on 4th January, 1980 by the Durham County Council, County Hall, Durham.
