2.	AH welcomed everyone to the meeting.	
	The minutes from the previous meeting were confirmed as accurate.	
3.	Update presentation	
	CM gave an update presentation, including;	
	 Towns Deal finances. Early warning of projects at risk of deliverability were outlined and made transparent to the board. Provided an overview of the requirements for the Monitoring & Evaluation performance evaluation to be returned to DLUHC by 16th December. This was addressed in further detail in item 4 of this Board meeting. Updated on the ongoing Towns Fund projects. 	
	Work continues in Skinnergate, Yards & Post House Wynd with no major concerns or issues for the board. Several key milestones have been achieved with more to be delivered.	

An update was provided on progress with the proposed urban green space on Commercial Street, Northgate.

A draft design layout for the ground floor of the Northern Echo Building for the proposed Adult Skills has been agreed. Preliminary Market Testing for use of the whole building is currently out to tender via NEPO. Risk appraisal is underway, and a business case is to be developed which considers the whole building.

Completion of the TLevels project is expected in early February. Expected to be achieved within budget. An opening event is to be coordinated.

Concept designs for the Garden Street area are developed. Awaiting outcome of LUF proposal.

DBC Cabinet have agreed to progress the process for Compulsory Purchase Order of Northgate House, should this be required. A further revised offer is to be sent to the Owner of the building following this Board meeting.

156 Northgate has now been acquired. A tender process has been undertaken to secure full design services. The return will be reviewed and if acceptable award made to progress the development of this project.

Victoria Road project has progressed the creative strategy and development of improvement opportunities. Item 5 of this Board meeting addresses this further.
