### DARLINGTON BOROUGH COUNCIL ROAD TRAFFIC RESTRICTIONS (AMENDMENT NO.1) ORDER 2023

Darlington Borough Council ('the Council') in exercise of its powers under 1, 2, 4 and 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') and of all other enabling powers; and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order.

# PART 1 DARLINGTON BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING) CONSOLIDATION ORDER 2019

- 1. The Darlington Borough Council (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2019 (as amended) ('the Prohibition and Restriction of Waiting and Loading Order 2019') is amended as follows:
- 1.1 The length of road detailed in Schedule One to this Order is added to Schedule 3.01 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.2 The length of road detailed in Schedule Two to this Order is added to Schedule 5.01 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.3 The length of road detailed in Schedule Three to this Order is added to Schedule 5.04 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.4 The lengths of road detailed in Schedule Four to this Order are deleted from Schedule 6.01 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.5 The lengths of road detailed in Schedule Five to this Order are added to Schedule 6.01 to the Prohibition and Restriction of Waiting and Loading Order 2019

- 2.4 The length of road detailed in Schedule Nine to this Order is added to Schedule 60.01 to the Moving Traffic Order 2019

- 2. To introduce No Waiting and No Loading/Unloading 10am 5pm in the lengths of road set out in Schedule Two.
- 3. To introduce No Waiting and No Loading/Unloading Mon-Fri 8.30am-9.15am and 2.45pm-3.45pm in the length of road set out in Schedule Three.
- 4. To remove No Waiting at any time in the length of road set out in Schedule Four.
- 5. To introduce No Waiting at any time in the length of road set out in Schedule Five.
