Partnership function:

Darlington Safeguarding Partnership is the key statutory mechanism for safeguarding responsibilities which are placed on Police, Health and Local Authorities to work together to safeguard and promote the welfare of children and adults with needs for care and support. The three organisations have equal responsibility for setting out the safeguarding arrangements and to ensure the effectiveness of safeguarding practice across Darlington.

Objectives for the year

Darlington Safeguarding Partnership has a strong collective oversight of safeguarding arrangements to ensure all agencies are fulfilling their statutory obligations, it will do this by:

- Ensuring there are effective safeguarding arrangements in place to protect and promote the
 welfare of children and adults with needs for care and support who are at risk of abuse,
 neglect, injury or harm.
- Ensuring there are effective scrutiny and assurance arrangements in place across the partnership.
- Having detailed governance and structure arrangements in place to ensure the appropriate processes and systems are robust.
- Exploring how the Partnership can develop a more integrated approach to strengthening and develop safeguarding partnership arrangements.
- Setting out the structure and how the groups will support and develop the work of the partnership.
- Ensuring the voice of children and vulnerable adults is evident across multi-agency work.

Performance against objectives

Darlington Safeguarding Partnership will:

- Ensure all partner agencies work effectively and collaboratively to protect and safeguard children and adults with needs for care and support from abuse and neglect.
- Ensure partners challenge and hold one another to account effectively.
- Ensure its governance arrangements are effective.
- Ensure early identification and analysis of new safeguarding issues and emerging threats.
- Ensure information is shared effectively to facilitate more accurate and timely decision making for children, families and adults with need for care and support.
- Ensure learning and improvement processes including Child Safeguarding Practice Reviews and Safeguarding Adult Reviews are undertaken.
- Ensure learning is promoted and embedded across the partnership.
- Monitor performance through Performance Management Frameworks and quality assurance processes.
- Continues to work closely with other key relevant agencies and Partnership Boards to ensure safeguarding of children, young people and adults with care and support needs are threaded throughout.

Objectives for next year

Implement the new multi-agency Safeguarding Partnership arrangements with the requirements outlined in Working Together to Safeguard Children Statutory Guidance 2023. The guidance introduced substantive changes to strengthen safeguarding arrangements including the introduction of a partnership chair, emphasise the role of education, strengthening accountability and

expectations for information sharing, independent scrutiny, funding and reporting. The changes will be effective from 1 April 2025.

DSP will continue to provide an annual report to summarise the work of the partnership. It will continue to:

- Apply learning from local and national Child Safeguarding Practice Reviews and Safeguarding Adult Reviews into practice
- Ensure partners work collaboratively to strengthen existing practice with a focus on a 'whole family approach'
- Strengthening quality assurance processes and further develop performance frameworks to provide the assurance partners need in relation to multi-agency safeguarding arrangements
- Continue to review ways of working to ensuring there is a strong collective oversight of safeguarding arrangements and to seek assurance that everyone is working closely together.
- Continue to evidence impact of work of the partnership and explore how to obtain the lived experiences of children and vulnerable adults
