

**DARLINGTON BOROUGH COUNCIL  
(PUBLIC FOOTPATHS 1 AND 2  
LITTLE STAINTON)  
DIVERSION ORDER 2023**

The above named Order made on the 19th October 2023 under section 119 of the Highways Act 1980 was confirmed on the 29<sup>th</sup> November 2023 without modification. The effect is to divert the lengths of public footpath described in Part 1 of the Schedule to the routes described in Part 2 of the Schedule below. The routes of the footpaths run through The Mount Farm, Little Stainton and can be seen marked on the Order Map. The Order comes into effect on the 13<sup>th</sup> December 2023. A copy of the Order and the Order Map have been placed and may be seen free of charge at Darlington Borough Council, 17 Allington Way, Darlington DL1 4QB from 9.00 a.m. to 4.30 p.m. Mondays to Fridays. If a person aggrieved by the Order desires to question its validity, or that of any provision contained in it, on the grounds that it is not within the powers of the above Act, or on the ground that the requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of that order, they may apply to the High Court for any of the purposes within six weeks from the date of this Notice.

Footpath No. 1 Little Stainton	Starting at Point A - NZ 29796 18561 20443 heading in a north west direction along the field edge through the following points B - NZ 32977 20489, C - NZ 32956 20509, D - NZ 32942 20538, E - NZ 32938 20559, F - NZ 32925 20569 and G - NZ 32913 29574 to Point H - NZ 32895 20590 - The width is 2 metres
Footpath No. 2 Little Stainton	Starting at Point I - NZ 32711 20684 heading in a north east direction along the fence line through the following points J - NZ 32731 20733, K - NZ 32733 20747, L - NZ 32744 20770 and M - NZ 32745 20780 to Point N - NZ 32788 20871 - The width is 2.5 metres
