DARLINGTON BOROUGH COUNCIL ROAD TRAFFIC RESTRICTIONS (AMENDMENT NO.1) ORDER 2024

Darlington Borough Council in exercise of its powers under 1, 2, 4, 32, 33, 35, 45, 46, 47, 49, 51 and 53 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') and of all other enabling powers; and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order.

PART 1 DARLINGTON BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING) CONSOLIDATION ORDER 2019

- 1. The Darlington Borough Council (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2019 (as amended) ('the Prohibition and Restriction of Waiting and Loading Order 2019') is amended as follows:
- 1.1 The lengths of road detailed in Schedule One to this Order are deleted from Schedule 6.01 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.2 The lengths of road detailed in Schedule Two to this Order are added to Schedule6.01 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.3 The length of road detailed in Schedule Three to this Order is added to Schedule 7.03 to the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.4 The interpretation detailed in Schedule Six to this Order is added to those set out in Part 2 of the Prohibition and Restriction of Waiting and Loading Order 2019
- 1.5 The exemption detailed in Schedule Seven to this Order is added to those set out in Part 4 of the Prohibition and Restriction of Waiting and Loading Order 2019 and shall apply to the restrictions detailed in articles 3 and 5-22 of the Prohibition and Restriction of Waiting and Loading Order 2019

PART 2 DARLINGTON BOROUGH COUNCIL (ON STREET PARKING PLACES) CONSOLIDATION ORDER 2019

- 2. The Darlington Borough Council (On Street Parking Places) Consolidation Order 2019 (as amended) ('the On Street Parking Places Order 2019') is amended as follows:
- 2.1 The length of road detailed in Schedule Four to this Order is added to Schedule23.01 to the On Street Parking Places Order 2019

- 2.2 The length of road detailed in Schedule Five to this Order is added to Schedule 25.03 to the On Street Parking Places Order 2019
- 2.3 The interpretation detailed in Schedule Six to this Order is added to those set out in Part 2 of the On Street Parking Places Order 2019
- 2.4 The exemption detailed in Schedule Seven to this Order is added to those set out in Parts 3(D), 5(B) and 6(B) of the On Street Parking Places Order 2019

PART 3 DARLINGTON BOROUGH COUNCIL (OFF STREET PARKING PLACES) CONSOLIDATION ORDER 2019

- 3. The Darlington Borough Council (Off Street Parking Places) Consolidation Order 2019 (as amended) ('the Off Street Parking Places Order 2019') is amended as follows:
- 3.1 The interpretation detailed in Schedule Six to this Order is added to those set out in Part 2 of the Off Street Parking Places Order 2019
- 3.2 The exemption detailed in Schedule Seven to this Order is added to those set out in Part 7 of the Off Street Parking Places Order 2019

PART 4 DARLINGTON BOROUGH COUNCIL (RESIDENTS PARKING) CONSOLIDATION ORDER 2019

- 4. The Darlington Borough Council (Residents Parking) Consolidation Order 2019 (as amended) ('the Residents Parking Order 2019') is amended as follows:
- 4.1 The interpretation detailed in Schedule Six to this Order is added to those set out in Part 2 of the Residents Parking Order 2019
- 4.2 The exemption detailed in Schedule Seven to this Order is added to those set out in Article 13 of the Residents Parking Order 2019

PART 5 GENERAL

5. This Order is entitled the Darlington Borough Council Road Traffic Restrictions (Amendment No.1) Order 2024 and shall come into effect on the

 All other provisions of the Prohibition and Restriction of Waiting and Loading Order 2019, the On Street Parking Places Order 2019, the Off Street Parking Places Order 2019 and the Residents Parking Order 2019 not affected by this Order will continue in full force and effect

DARLINGTON BOROUGH COUNCIL ROAD TRAFFIC RESTRICTIONS (AMENDMENT NO.1) ORDER 2024

Notice is hereby given that Darlington Borough Council proposes to make the above named Order under Sections 1, 2, 4, 32 and 35 of the Road Traffic Regulation Act 1984 and of the Traffic Management Act 2004. The following restrictions are being proposed to be introduced:

- No waiting at any time in the following lengths of road: Outram Street - the east side, from a point 16.3 metres to a point 22.3 metres north of its junction with Duke Street Faverdale West – the north side, from a point 150 metres to a point 180 metres west of its junction with Faverdale North; the south side, from a point 146 metres to a point 157 metres west of its junction with Faverdale North; the south side, from a point 193 metres to a point 203 metres west of its junction with Faverdale North
- 2. No waiting 9am-5pm Mon-Sat in the following part of Outram Street: the west side, from a point 5.4 metres north of its junction with Duke Street to its junction with Duke Street North Back
- 3. The following part of Outram Street shall be designated a disabled parking place from 8am-6pm all days with a maximum wait of 3 hours, and no return within an hour:

the east side, from a point 22.3 metre north of its junction with Duke Street to its junction with Duke Street North Back

4. The following part of Outram Street shall be designated a limited waiting parking place Mon-Sat from 8am-6pm with a maximum wait of 2 hours, and no return within an hour:

the east side, from a point 5.4 metres to a point 16.3 metres north of its junction with Duke Street

5. To introduce an exemption to the following restrictions for vehicles being used by a civil enforcement officer whilst carrying out their duties - parking in off street and on street pay and display and pay on foot parking places, loading bays, residents parking places, clearways and on roads which have waiting and loading restrictions

These proposals which affect Outram Street replace those advertised on the 21st July 2023. The Order will amend the Darlington Borough Council (Prohibition and Restriction of Waiting and Loading) Consolidation Order 2019; the Darlington Borough Council (On Street Parking Places) Consolidation Order 2019; the Darlington Borough Council (Residents Parking) Consolidation Order 2019 and the Darlington Borough Council (Off Street Parking Places) Consolidation Order 2019 . 
