The Order comes into force on the 27th January 2010, but if any person aggrieved by the Order wants to question its validity or that of any provision contained in the Order on the ground that it is not within the powers of the above Act or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order he or she may make an application to the High Court for any of these within six weeks from the date of this Notice.

LENGTH OF PUBLIC RIGHT OF WAY TO BE EXTINGUISHED

Public Footpath No. 26 Darlington - From OS Grid Reference NZ 31185/16124 (adjacent to 82 Welbeck Avenue) south eastwards to NZ 31207/16107, then south south west to NZ 31200/16091, then south south east to NZ 31225/16073 (between Nos 35 and 37 Stockton Road). The width of the footpath is one metre.

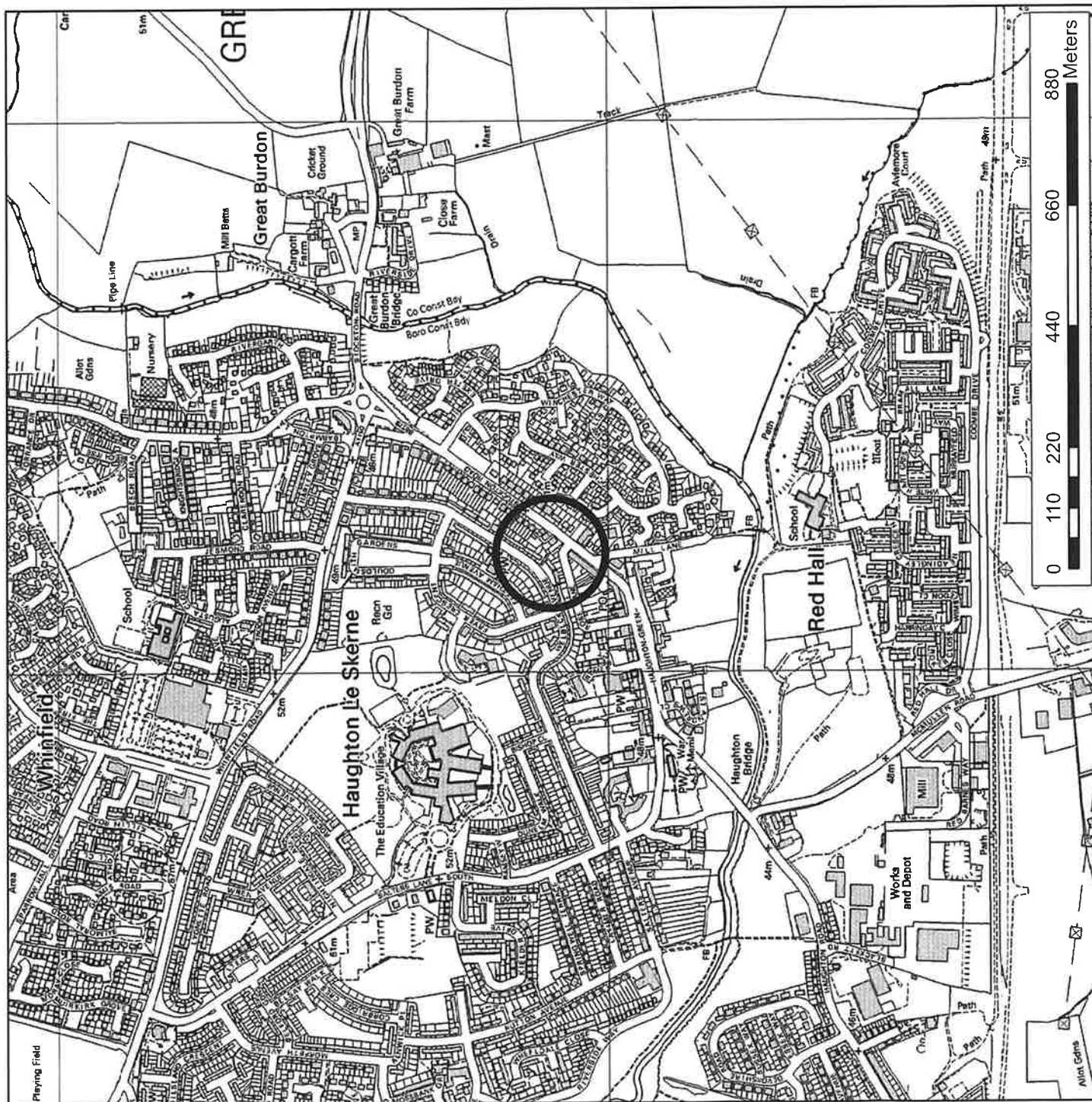
