Footpath No. 3	From Point B on the attached map (OS Grid Reference NZ23360/15719) south south west for 217 metres to Point E (NZ23278/15520) where it connects with Footpath No. 4, High Coniscliffe. The width is unspecified.
Bridleway No. 1	From Point A (NZ23096/15780) eastwards for 276 metres to Point B (NZ23360/15719), then northwards for 748 metres to Point C (NZ23450/16450). The width is unspecified.

PART 2 DESCRIPTION OF SITES OF NEW PATH AND WAY IN HIGH CONISCLIFFE

Footpath No. 3	From Point G where it connects with Bridleway 1, High Coniscliffe (NZ22996/15636) east south east for 103 metres to Point F (NZ23083/15598) to connect with Footpath 4, High Coniscliffe. The width is 2 metres
Bridleway No. 1	From Point A (NZ23096/15780) northwards, following the bank of Ulnaby Beck for 764 metres to Point D (NZ23237/16428) where it meets the disused railway line, then eastwards for 207 metres to connect with the existing bridleway at Point C (NZ23450/16450). The width is 3 metres.
